Waiver and Release of Liability

I hereby knowingly and voluntarily enter into this Agreement and waive any and all rights, claims, or causes of action of any kind whatsoever arising out of participation in the Sweepstakes; and do hereby release and forever discharge the Commission, its members, agents, servants, employees, volunteers, successors, and assigns (collectively, the "Commission"), located at 3250 West Britt David Rd., Columbus, Muscogee County, Georgia, from any injury to the Participant, including but not limited to illness, paralysis, death, damages, economic or emotional loss, that may be suffered as a direct result of participation in the aforementioned Sweepstakes.

I acknowledge that the Commission will own such Images and further grant permission to copyright, display, publish, distribute, use, modify, print, and reprint such Images in any manner whatsoever related to the Commission's business, including, without limitation, publications, advertisements, brochures, website images, social media posts or other electronic displays and transmissions thereof. I further waive any right to inspect or approve the use of the Image by the Commission prior to its use.

I (on behalf of myself, and if a parent or guardian, on behalf of the Participant), agree to indemnify and hold harmless the Commission against any and all claims, suits, or actions of any kind whatsoever for liability, damages, compensation, or otherwise brought by Participant or anyone on Participant's behalf, including attorney's fees and any related costs, if litigation arises pursuant to any claims made by Participant or by anyone acting on Participant's behalf.

I acknowledge that I have carefully read this Agreement and fully understand its contents. I understand and agree that no oral or written representations will alter the contents of this Agreement. I acknowledge that this Agreement will be governed by and construed in accordance with the laws of the State of Georgia (excluding conflict of laws principles).
